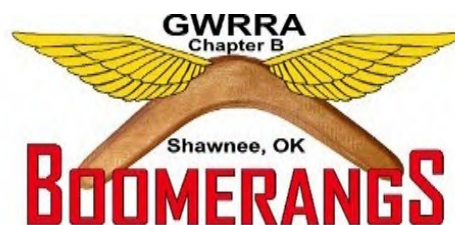
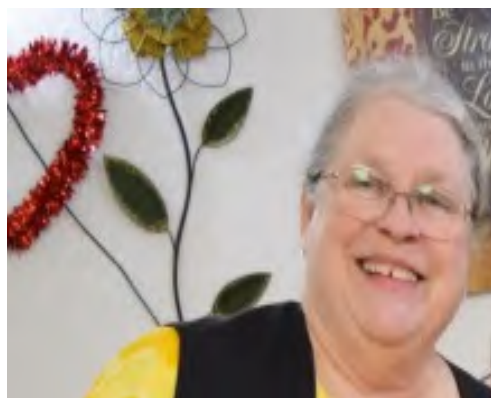

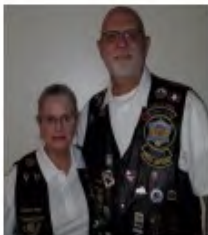

# Beef stew made in the crock pot

## Ingredients:

1 lb beef stew meat  
2-3 large russet potatoes washed and peeled and chopped  
4 large carrots washed peeled, and chopped  
2-3 ribs of celery chopped  
1 large onion chopped  
1 ½ cup frozen peas  
15 oz canned Diced tomatoes  
1 ¼ cup of sliced mushrooms  
2 tsp of minced garlic  
32 oz beef broth  
1/3 cup of all purpose flour  
1 tsp of crush basil  
1 tsp rosemary leaves  
½ tsp of oregano  
2 tbsp salt free seasoning or 2 tsp of salt  
½ tsp of ground black pepper  
2 tbsp of vegetable oil  
2 tbsp of cornstarch

## Directions:

Pour vegetable oil into a skillet, and place over medium heat.

Coat the meat with the flour , and once the oil is hot brown the meat.

Remove the meat from pan and pour in the beef stock

Toss the meat back in pan , and cook for 2 minutes , then remove from heat

Toss all the vegetables in the crock pot along with the meat , and seasonings.

Cook on high for 3 hours

Dish out about 1 cup of beef broth and add 2 tbsp of cornstarch to it. Whisk.

Pour the thickened stock back into the slow cooker . Mix and let sit for 5 -10 minutes.

Serve and enjoy.
