



Guns For Teachers

I, like many of you, consider California to be on the left wing fringe of all political issues. Yet on gun control there is a large comparatively quiet group. They do not want more regulations. In fact, on calling for armed teachers which with the state's county regulations have some validity.

There are ten states currently that allow "with certain restrictions" teachers to carry guns in schools. The issue for many people is that in rural areas police departments are spread very thin. You do not have to look very far to find communities here in Illinois, as they do in California, that the Police force is one or two people and response time due to large farms and railroad crossings can be 20 - 30 minutes on a good day. The people in schools in these areas in reality are often on their own -- all or almost all people in these areas are familiar with and respectful of firearms. It's not like Chicago, LA or San Francisco, who in an emergency at a school would have a response within two minutes.

I have heard many parents, teachers and politicians say they would not feel safe. R. V. Scheide, a concealed carry trainer in Northern California, states that the training is rigorous and that about 25% of the teachers in his area already had concealed carry permits. Many do not take the extra training, some reasons appear to be fear of law suits, and fear that too much would be expected of them.

David Dominguez, a former Marine and Policeman, is a concealed carry trainer in California and reminds people that armed teachers do not become the aggressor. They stay with the students they are assigned and force is their last alternative.

The teacher with the right to carry in Northern California already have the training and are vetted. But, as usual, "gun free zone acts" has made it very hard, but not impossible, to allow your teachers to carry. Though only rural areas seem to have used this loophole. At a hearing about the law, the head of the Board of Ed stated "I disagree with you about use of guns. I disagree that an educator today can't talk down a shooter." Mr. Dominguez reminded them at the same School Board meeting that most school shooters come with a plan that includes suicide or suicide by cop. The loophole was further closed for most.

In Florida after the Parkland incident new restrictions were passed. But it does call for a voluntary program that permits armed teachers. Some people have publicly stated they are more afraid with more guns in the schools. Think about that. If you have teachers you would fear having a gun, why is that teacher on your staff? There is almost no adult who could not bring a gun to school. So if you don't trust your teachers, be careful.

The one thing as an administrator I would worry about is never tell anyone you are one of the up to 20% of the teachers to help in a school. My 18 years as a principal kept me constantly on the alert. If one of those people came in to school, if the shooter knows who is armed that is the first person they would take out. Or, attack that person to steal the gun. That is why training must be optional and rigorous. All Chicago high schools have on duty police and other schools have purchased off duty police services. So many of our schools are taken care of. But if you were in a rural area, you might think otherwise.


Brookfield Zoo Plans Events

Propose Tax Relief For First Responders

State Rep. Silvana is supporting legislation that would provide new property tax relief for police officers and firefighters who suffered a serious injury in the line of duty and for the families of first responders killed serving the community.

She is a chief sponsor Senate Bill 3197 which would create a new \$5,000 homestead exemption for police officers and firefighters who have been paralyzed or seriously injured in the line of duty beginning with taxable year 2019. In order to qualify for the exception, the officer of firefighter must have suffered an injury resulting in paraplegia, quadriplegia or dismemberment.

Surviving spouses of a first responder killed in the line of duty will also be eligible.


Healthy Tips For Swimming

"Swimming is a great physical activity that can help improve your health, as long as you take some simple steps," said Illinois Department of Public Health Director Nirav D. Shah, M.D., J.D. "When you get to the pool, check if you can see the drain at the bottom of the deep end, and look for safety equipment if a lifeguard is not on duty. Remember to shower before getting in the water, and if you are sick or have been sick recently, don't swim."

Diarrhea is the most common cause of recreational water illness. Just one diarrheal or vomiting accident in the water can release millions of germs. If other swimmers swallow a mouthful of the water, it can cause diarrhea lasting up to three weeks.

Cryptosporidium is the leading cause of outbreaks linked to pools and water parks. Crypto can survive in an adequately chlorinated pool for more than one week. Other germs that can cause illness include *Giardia*, norovirus, *Shigella* and *E. coli*. RWIs can also be caused by chemicals added to treat water. Other common illnesses include skin, ear, respiratory, eye, neurologic, and wound infections.
