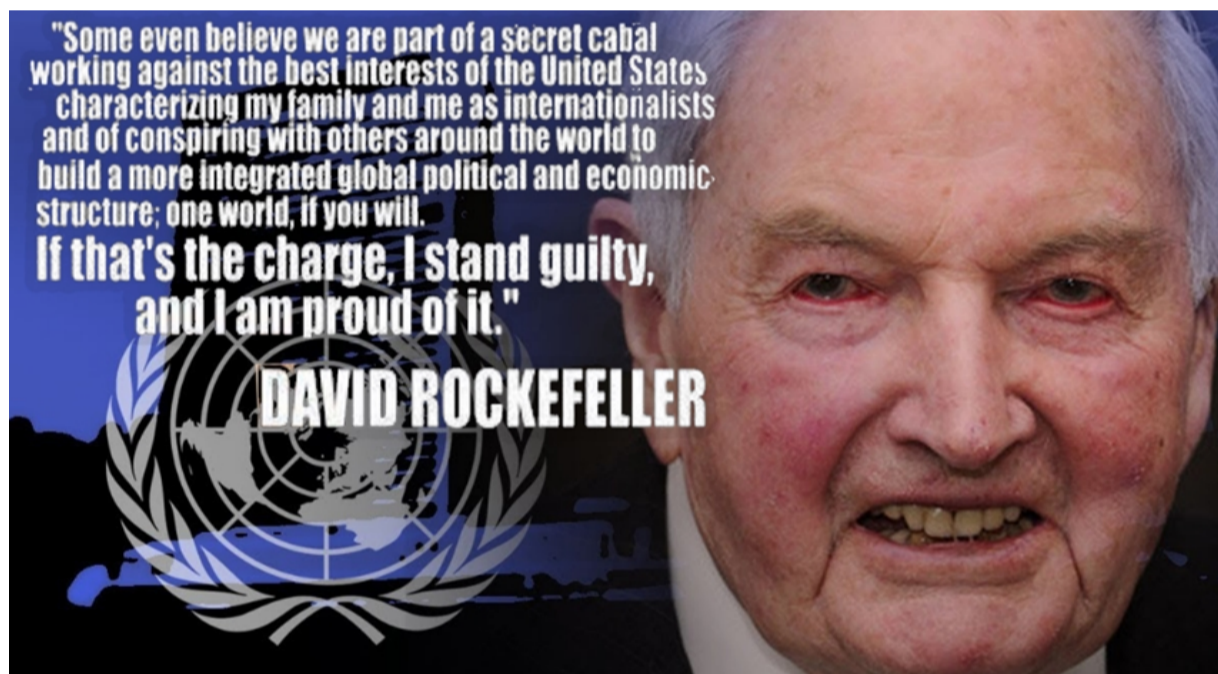
There can be no unity in Evil.
