



## POW/MIA Recognition Day

September 15th is POW/MIA Recognition Day. I was told by some high school students that they often read my articles because they deal with things that are new to them and just in case they are reading, I want them to know Prisoner Of War and Missing In Action are what the letters stand for. Today these numbers are very low because we are aware that to be captured might lead them to be treated inhumanely and we have even seen some of them beheaded.

I don't want anyone to think that this is new. During the American Revolution more soldiers died from illness and starvation while POWs than did during actual combat. During the Civil War, or War Between the States, thousands died in captivity. No one knew how to handle, feed, or give sanitary dwellings for such large numbers. In Andersonville, GA up to 45,000 Union prisoners were housed there with approximately 13,000 of them dying because of the conditions.

Here in Chicago was Camp Douglas. It was from about Cottage Grove to King Drive and 31st to 35th Streets. In those days, it was swamp land and flooded almost every time it drizzled. A little known fact was that the prisoners were allowed to attend church services in the area - escape? No place to go. Because of the good people, some of these prisoners received their only good meal for the week. In fact, the records of St. James Catholic Church on 29th Street indicate the Baptisms of over 250 Confederate prisoners during the war. How did

### Data Breach At Equifax

Attorney General Lisa Madigan announced an investigation into the massive data breach of consumer reporting agency Equifax which affecting at least 143 million Americans. Information compromised includes Social Security numbers, driver's license numbers, names, dates of birth, credit card numbers and addresses, creating a perfect opportunity for identity theft.

Madigan said, "I urge every Illinois resident to take precautions such as placing a freeze on your credit to reduce any damage likely to occur as a result this data breach." Madigan called on Equifax to suspend its charge for placing a credit freeze on their accounts in light of the significant risk of identity theft.

you get out of this prison? As the war was drawing to a close, the soldiers were allowed to join the Union Army to fight in the Indian Wars, up to ten companies were formed this way. After Appomattox the soldiers lower than Colonels could sign a Loyalty Oath and sent on a train South. If they would not sign the Loyalty Oath, they could leave, but they were on their own to walk home.

These conditions seem cruel, but nothing like WWII. If you don't recall the Bataan Death March, it is a good historic study or you might like movies that are historical fiction like "The Great Escape" and "Bridge over the River Kwai". A recent release considered historically accurate is "Unbroken".

Prisoners during Korea and Viet Nam continued long history of brutal treatment and "brain washing" was brought to our knowledge. The definitive Viet Nam POW movie is "Hanoi Hilton". It is hard to find but well worth the effort. It has been suggested that rich people who had friends depicted poorly helped to pull this movie out of circulation. There are still about 2500 still unaccounted for in Southeast Asia. The Soviet Union admitted that they, along with Communist China, took many POWs to their countries to interrogate, but claim their records show they were returned to North Viet Nam by 1972.

When the Peace Accord was signed in 1973, all prisoners were to be returned. Few believe this is true. So for these 44 years many families have been holding out hope, even if only for a confirmation or the possibility of an interment. These families realize they have little possibility of their loved ones being alive. If you wish to read an official document on the subject "The Americans Missing in Action in Southeast Asia....US House of Representatives 1976" is a good place to start.

Now just think of the enormity of WWII. There are at least 82,000 still unaccounted for. Those people were someone's spouses, siblings and parents. War, while it may be necessary, is never without pain. If only one person dies, it might be someone you loved. If you know any POW or MIA family, share your empathy with them and pray for those missing.

## CPS Reports Academic Progress

Chicago Public Schools released its annual academic progress report, a comprehensive overview of students' record-breaking progress since 2011 on key academic measurements.

**Record-High Graduation Rate:** The percentage of students graduating hit an all-time high of 77.5 percent in 2017 - a 4-point improvement from the previous year.

**Freshmen On-Track:** This year's rate of freshmen on-track to graduate is the highest measure on record at 88.7 percent, up more than 28 percent since 2011.

**Math and Reading Gains:** In recent years students achieved record scores on the Northwest Evaluation Association Measure of Academic Progress. In 2017, a record 61.4 percent of students met or exceeded the national testing average in reading and 55.9 percent of students met or exceeded the average in math.


**Scholarship Dollars Earned:** The class of 2017 earned more than \$1.24 billion in scholarship offers - \$80 million more than 2016 and triple the amount of scholarship dollars earned in 2013.

**Keeping Students Safe:** Since 2011, more than 100 schools were added to the Safe Passage program to help

ensure that more than 75,000 students from 145 schools are able to travel safely to and from school every day. To date, there have been no serious incidents involving a student during operational hours while workers are present, and crime along routes has decreased 32 percent since 2012.

**Meeting Students' Social and Emotional Needs:** major investments in social and emotional learning programming, training and initiatives in recent years. The supportive schools certification to recognize schools have prioritized supportive school environments. In 2017, 335 schools earned the supportive school certification, an increase of more than one-third since 2016.
