Hot Air Balloon At Columbia Explorers



14th Ward Alderman Edward M. Burke (left) presented a City Council resolution to World War II veteran Glenn Shelton Key which recognized May 28th as Glenn Shelton Key Day throughout Chicago. Mr. Key opened the City Council's most recent meeting by leading aldermen in the Pledge of Allegiance and received a resounding ovation of applause from the gallery. A Navy veteran, he was aboard the lead command landing ship tank (LST) to storm Omaha Beach during the amphibious assault on Normandy, France. Glenn was scheduled to be among 90 World War II vets to fly out of Midway Airport on June 4th on an Honor Flight to visit memorials in Washington, D.C. two days before the 70th anniversary of the D-Day landings. The Honor Flights Chicago program is provided free of charge as a way to recognize World War II-era veterans. Organizers of Honor Flight Chicago emphasize that there are still 21,000 World War II area veterans who have yet to participate in this free program. Weekend Closures For I-90/94 X-Way

The Illinois Department of Transportation announced that weather permitting, demolition of the westbound Ohio/Ontario Street Bridge to eastbound I-90/94 over I-90/94 (Kennedy Expressway), will begin Friday, June 13. This large-scale demolition will occur over the course of three separate weekends. Due to the type of bridge, a three-unit, eight-span, concrete structure with the supporting columns constructed integral into the bridge, it cannot be disassembled in pieces, but must be removed one unit at a time. Motorists can expect significant delays and back-ups and should seek alternate routes. Drivers are urged to pay close attention to flaggers, watch for signing in the work zones, obey the posted speed limits, and be on the alert for workers and equipment. Graduation Day

Graduation: Simply stated, in schools is a way of celebrating movement from one step in the educational process to another. If the party afterwards is to celebrate that accomplishment, that is good, as long as one does not go overboard. When I was a teacher at the Metcalfe School we had a Kindergarten boy come to graduation in a white tuxedo with a cane and brought by a limousine. A little overboard? I hope you agree with me that it is. With any graduation from Kindergarten you have no criteria you need to accomplish, except to be five before the next school year begins. I never allowed Kindergarten graduations in my 18 years as a principal. What's the accomplishment? Parents say, "Oh but they're so cute." Well you can always have a puppy day, those would be cute pictures too.

Grade school is almost as bad. Some people rent halls. I've had neighbors who had their graduate son vomiting all over my front yard. Boy that's showing how to respect education and what they've accomplished.

In CPS you can only be retained once and you will graduate regardless of grades and attendance if you are going to be 15 before the next school year. Of course, these are the kids whose parents have the biggest parties. I always preached to my kids to be dignified, because it's the family that screams and yells when their names are mentioned in the most surprised the student graduated, and is probably sure it will be the only

graduation that child ever has.

My brother-in-law graduated from a K-12 Catholic school in Western Pennsylvania. Their ceremony from going from 8th to 9th grade? They got to move their lockers from the first floor to the second floor, and most of these kids went on to college. I have come across schools that have such elaborate programs for their 8th graders and so many activities that the graduation fee becomes too high for most parents to pay, so they spend the year having fundraisers. I'm not sure this leads to any significance to accomplishments.

In the mid-90's as assistant principal at the Nathan Davis school we had about 112 graduates and it was extremely hot. We had several students pass out on the stage. But, I had a parent come up to me and ask that I help pick her son up or he would miss the pictures.

In the 70's the norm was to let the kids express themselves. They dressed as they wanted and we were told that almost anything goes. The problem with this is that once again we are separating the "haves" and the "have nots". The "haves" are already having big parties and will show up in the best clothes. I have had "have not" students avoid graduation, as they would not accept charity. I'm glad to say that most schools graduate with Cap and Gown now and this is a great equalizer and when done right, can add to the solemnity of the ceremony.

High School graduation should be appreciated more because there are a whole set of requirements that the student must have obtained in order to be eligible for that diploma. In many of the situations in our neighborhood and the other neighborhoods I have taught in, that young man or woman may be the very first to actually graduate high school. For many families this is a great accomplishment that should be celebrated. I know several people who, while proud of their children, did not get to elaborate because they knew this was not going to be the last graduation for that child.

So parents and friends, during this graduation time, make sure you are celebrating because of the child's accomplishments, not so you can have a party.
