End of Civil War Commemorated



14th Ward Alderman Edward M. Burke (center) presided over a ceremony at the St. Jane de Chantal Church bell tower to mark the 150th Anniversary of the end of the Civil War. All places of worship in Chicago were encouraged to toll their church bells at 2:15 p.m. on April 9th, recalling the moment when Confederate General Robert E. Lee surrendered to Union General Ulysses S. Grant at Appomattox Court House, Virginia. The local ceremony coincided with the ringing of bells across America at historical sites such as Appomattox Court House in Virginia and the Old North Church in Boston, as well as churches, parks, historical sites, and museums, in at least 37 states. Also pictured are: 18th Ward Alderman-Elect Derrick Curtis, 23rd Ward Alderman Michael R. Zalewski, Congressman Daniel Lipinski and Deputy Mayor Steve Koch. Mayor Rahm Emanuel issued a statement praising Burke, the City Council's unofficial historian, for organizing the sesquicentennial event. "Let us hope that in the spirit of Abraham Lincoln, the "Great Emancipator" who lost his life to an assassin's bullet just six days after the surrender at Appomattox, that his quest to bind up the nation's wounds in the aftermath of Civil War will live on in our evolving world," Burke said.

The muralist, print-maker, painter, mentor and tour guide was born in San Antonio, Texas, in 1938. In search of work and adventure, he traveled to the Midwest in the early 1960s and since 1964, has made Chicago his home.

In the early 1970s, Jose met John Pitman Weber who introduced him to the Chicago Mural Group (now known as The Chicago Public Art Group), where Jose began as an apprentice, was an

active member, and in 2005 was recognized as a First Generation Muralist.

Jose and his wife Margaret founded the Pilsen Mural Tours in 1980 and conducted walking tours to school, cultural, and artist groups in an effort to share the history of immigrants. In 2001, Travel Adventures of Michigan gave Jose its Outstanding Guide Award.

In 2003, Jose was invited to Whitworth College of Spokane, Washington, where he initiated their Visiting Artist Program with workshops focused on his linoleum printmaking process.

In 2008, inspired by his friendship with the late printmaker Carlos Cortez, Jose, along with his wife Margaret and friend Leticia Guerrero, founded Obrero Press, a community-based print-making studio at 1438 W. 18th st.

To mark the 100th anniversary of the Armenian Genocide and the death and displacement of millions of Armenians, a descendant of the survivors has created an enormous work of art to both honor the victims and survivors and to celebrate the enduring strength and culture of the Armenian people.
