ADDITIONAL APPROPRIATION RESOLUTION


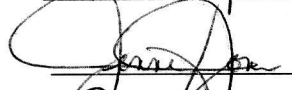

Whereas, it has been determined that it is now necessary to appropriate more money than was appropriated in the annual 1999 budget; now therefore:

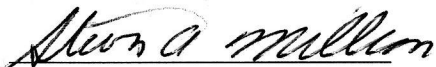
