17,462 New Cases Of COVID-19

The Illinois Department of Public Health reported 17,462 new confirmed and probable cases of coronavirus disease (COVID-19) including 183 additional deaths since Friday, Oct. 29th. Of Illinois' total population, 66% has received at least one COVID-19 vaccine dose and almost 61% is fully vaccinated.

On Nov. 3rd, IDPH adopted recommendation for children ages 5 to 11 years to receive the Pfizer-BioNTech COVID-19 vaccine which is administered as a series of two doses, 3 weeks apart.

IDPH is reporting 1,712,986 cases, including 25,948 deaths, in 102 counties. Laboratories have reported 820,983 specimens for a total of 36,109,599. 1,257 individuals were reported to be in the hospital with 282 patients in the ICU and 148 on ventilators.

The preliminary seven-day statewide positivity for cases as a percent of total test from Oct. 29th - Nov. 4th is 2.1%. A total of 15,911,477 vaccines have been administered as of Nov. 4th.

Skating Rink Opens At Brookfield Zoo

Brookfield Zoo's skating rink on the East Mall reopens Saturday, Nov. 13th. Bring the family to circle the rink, and then stroll around the park to see everyone's favorite animals.

The zoo's 40-foot x 80-foot skating rink is not made of ice, but of a synthetic plastic known as Glice®, a material composed of heat-pressed layers of polymers, so no water or electricity is required for operation. The rink will be open on Saturdays and Sundays, Nov. 13th-14th and 20th-21st, from noon to 4:30 p.m. It will also be open from 3 to 9 p.m. during the zoo's 40th annual Holiday Magic, Nov. 26th-28th and Dec. 1st-5th, 8th-12th, 15th-19th, and 26th-31st.

The cost for unlimited time for all skaters is \$7. A limited number of skates are available to rent for a \$5 fee. Skaters

are welcome to bring their own skates.

Create the ultimate winter outing and venture to Brookfield Zoo on one of its remaining Fall Free Days, presented by Xfinity—Nov. 11th, 16th-18th, and Thanksgiving Day (Nov. 25th), and December 6th-7th, 13th-14th, and 20th-21st. Veteran's Exemption For Property Tax



In honor of Veterans Day, the Cook County Assessor's Office would like to express gratitude to those who have served our nation by administering property-tax-saving exemptions for over 8,500 veteran families this year.

The Veterans with Disabilities Exemption is for a service-connected disability as certified by the U.S. Department of Veterans Affairs. The exemption reduces the Equalized Assessed Value on the primary residence of a veteran with a disability. Veterans are required to apply annually. Annual application is required.

The Returning Veterans Exemption is for those returning from active duty in armed conflict for eligibility to receive a \$5,000 reduction in the equalized assessed value of their property only for each taxable year in which they return. Annual application is required. "Veterans with significant service-related disabilities made sacrifices in service to our country and these exemptions are a way to recognize and honor them," said Assessor Fritz Kaegi (above).

The 2021 tax year

exemption application period will begin in early 2022. Veteran homeowners who believe they may have been eligible in prior tax years can apply for a Certificate of Error. The process provides homeowners an opportunity to redeem missing exemptions for the 2020, 2019, 2018, and 2017 tax years. For more information, visit www.cook-countyassessor.com.
