Out-of-District Residents = \$20.00 per person or group rate for 20 or more guests=\$18 per person

### Food and Drink Policies

### Inclement Weather

\_\_\_\_\_ (initials) SPAR Waterpark Staff has the right to cancel or close the facility based on unforeseen aquatic circumstances, weather, and/or public safety concerns. No refunds will be issued.

\_\_\_\_\_ (initials) If inclement weather causes the park to close for the day, and group arrived within two hours of time closed on original receipt, a Rain Check Admission Pass will be issued for 2024 season.

### Conditions and Expectations agreement of SPAR WATERPARK

- Lessee of facility agrees and understands that SPAR will at its' discretion, and only its discretion, determine facility availability.
