## Benefits of Homework

Homework! Just the mention of the word brings about different feelings and memories for almost everybody. I have had teachers who used it for punishment, I've had parents who thought it was more important than it was, I've had students who completely ignored it and lied to their parents. Let's take a look at the issue.

Latest research has shown that homework should be used to reinforce activities already taught in the classroom. Students should not be expected to learn concepts during homework, but they can be asked to memorize spelling, prayers, and other memory type activities. I've known many teachers who became overly aggravated by students not completing their homework. Ideally, it helps the student, but should not leave a gap in their work. It is time spent best elsewhere. Give the kid the zero and go on.

There are many groups affiliated with the schools

that want to help with homework, being it an after school program, club, a youth center, or even older sibling. This is fine, but for the most impact the parents must be involved. We, as parents, often talk about the importance of school but do little to show it. Students look at your actions, more than your words. Doing some of the homework with the students shows your interest and helps the parent prepare for conferences with the teachers. Help your student, do not do it for them. This simple advice sounds obvious, but after a day at work, it is a big temptation to help get it done. I had a fourth grader at the Yale School once tell me when I questioned his low score on the weekly Spelling test despite turning in all his work. His reply, "Come on teacher, don't you know my mother's handwriting yet?"

One of the most useful methods of helping is to set a time according to the parents' schedule to sit and help with the homework. It does not have to be the same time every day. But it should be when the parent knows that on that day, that week, they won't have anything more important to do than help with homework, and a parent, having set this time, should do everything humanly possible to give their child that time. Never accept "Oh, I did it at school". If so, fill that time with other activities, study spelling words, check times tables, help with CCD problems, or read a comic book. All these activities instill in your child that you, the parent, understand the

importance of school.

Parents and teachers should work with the child when they had to be absent. I have had many teachers send down the absent student's homework and many parents call for homework, but think about it. The student has been absent for about a six hour day. You're not going to make that up in a 30-minute session. Parents should ask for and receive the work their child missed during the entire day. It is also important that the work you see your child do is their own and is worthy of what they can do. These would be good guidelines whether your child is just starting or is finishing school.


