## A LETTER FROM OUR FOUNDER

As founder, CEO, and lead volunteer, of the Joseph Assignment Global Initiative, it is an honor and privilege partnering with you on the front lines of the global movement to eradicate poverty. Since our founding in 2005, your compassionate generosity has enabled our all-volunteer USA staff to apportion 100% of all donations directly into the mission field.

In 2019 alone, we have made tremendous progress in various extremely marginalized communities throughout the world. In Jamaica, our educational, cultural arts and sports initiatives have impacted youth and children living in poverty; facilitated development and provided technical support for micro farming businesses and local economies for individuals. 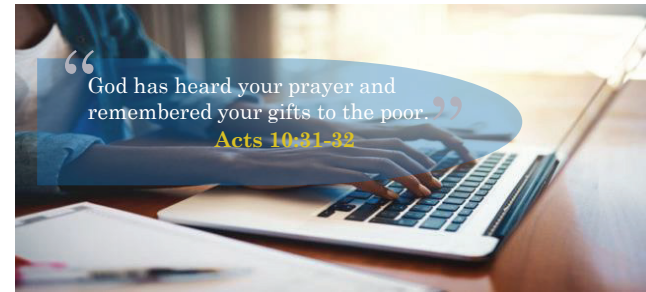

I was born in poverty and understand from personal experience the pain of the world's dispossessed, even those whose circumstances are even more dire than what I have known. My calling was clarified by the struggle to survive and succeed: to devote my life to ending global poverty.

Poverty is a human creation and requiring human solutions. According the World Bank, over the last decade almost a billion people have been lifted out of poverty, but in 2020, COVID-19 happened and set the clock back on their advancements. You should be proud as we are to have been a part of that global movement toward economic justice and the holistic value of human life. Yet there is much work to be done! According to the Brookings Institute, 600 million people globally currently live in extreme poverty, mostly in regions of South Asia and Sub-Saharan Africa, where much of our work is accomplished. We agree with the following United Nations description of poverty's multivariant causes and effects:

Poverty entails more than the lack of income and productive resources to ensure sustainable livelihoods. Its manifestations include hunger and malnutrition, limited access to education and other basic services, social discrimination, and exclusion, as well as the lack of participation in decision-making.

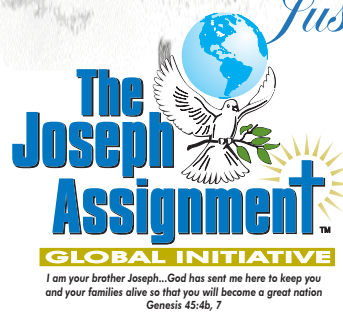

# CORE AREAS OF SERVICE

## EDUCATION

134 million children between the ages of 7 and 18 have never been to school. Girls are more likely to go without schooling than boys. Children are more likely to be forced into child labor if they are not attending school and more specifically, girls forced into sex trafficking.

## HEALTHCARE

Measles, malaria, and diarrhea are three of the biggest killers of children. More than 30 million children are not immunized against treatable or preventable diseases. 1 in 4 children who die before age 5 die of water-related diseases. Diarrheal diseases kill five times as many children in the developing world as HIV/AIDS.

## CLEAN WATER

Nearly 1.1 billion people do not have safe water to drink. A child dies every 15 seconds from unclean water. 2.3 million children die before age 5 due to water related diseases. Children and women often walk miles every day to collect dirty water to drink. 2.6 billion people lack adequate sanitation services.

## ORPHANS AND VULNERABLE CHILDREN

A staggering 53,100,000 orphaned children live in Sub-Sahara Africa. In India, approximately 12,400,000 orphans and almost 40,000,000 children are in need of help. An estimated 6,000 children are orphaned by AIDS every day. Children account for half of all civilian war casualties in Africa.



## SHELTER

More than 1 billion people are living in unsafe and impoverished living conditions. In most housing structures, 5 to 12 people share one 10' x 10' room. Structural quality is very poor and dangerous in most thatch and clay homes. Poor cramped housing promotes spread of infectious diseases.

## FOOD

Hunger kills more people every year than AIDS, Malaria, and TB. More than 900 million people go to bed hungry every day; 300 million are children, 5 million people die every year from hunger. Every day, almost 16,000 children die from hunger-related causes. Malnourished children suffer up to 16 days of illness every year.

## GREEN TECHNOLOGIES

In (Asia and Africa), especially in rural areas, 2.5 billion people rely on biomass, such as fuel, wood, charcoal, agricultural waste and animal dung, to meet their energy needs. These energy sources predispose families to hazards associated with smoke, fumes, CO, HC and other particulates.
