



## Archer Manor Little League Opens Season





## Earth Week At Sisters of St. Casimir



On Arbor Day, Friday, April 25th, the Sisters of Saint Casimir concluded the 2014 Earth Week with a special outdoor prayer service. ## CPL to Receive National Medal

The Institute of Museum and Library Services announced that the Chicago Public Library is one of 10 recipients of this year's National Medal for Museum and Library Service. The award will be presented by First Lady Michelle Obama at the White House on May 8th.

Chicago Public Library continues to expand its services for patrons of all ages in innovative ways. Its Maker Lab allows the public free, hands-on experience with 3D design software, 3D printers, and other 21st century tools. The library also expanded its YOUmedia digital learning opportunities for teens, and revamped the 2013 Summer Learning Challenge, which offered kids more ways to participate in creative learning activities and saw a record 71,000 participants. Patrons have access to physical and digital resources at all 80 locations.

The ten honorees exemplify the nation's diversity of libraries and museums and include a natural history museum children's museum, natural sciences museum, an aquarium, botanic garden, public library systems, and a book center.

## Nicor Gas Extends Winter Program

Nicor Gas is extending the deadline for its Extreme Winter Relief Fund to May 9th. The program was put into place in March to help more eligible customers qualify for heating assistance following one of the most severe winters in a decade.

Under the special program, eligible customers under 65 years of age are offered \$300 in assistance and \$350 for those 65 and older. Customers interested in applying for the special assistance program must meet all income and qualifying criteria and must have made a payment(s) totaling \$75 within the last 60 days of application date.

The Salvation Army-administered program is supported by contributions from Nicor Gas customers, employees and a company match. After May 9th, the program will return to its original guidelines and continue

to provide one-time grants to help qualifying families, as well as seniors and individuals with disabilities, to pay winter home heating costs. Qualified applicants must be a residential heating customer of Nicor Gas with a payment due and must have a household income between 150 percent and 200 percent of the federally established poverty level. They also must be ineligible for state or federal energy assistance programs.

## Selective Enrollment

The US News and World Report has published its annual ranking of the 31,200 public high schools in the United States and includes the 710 in Illinois. You might be surprised to find the results. In Illinois the rankings were #1 Northside College Prep; #2 Walter Payton; #3 Jones College Prep; #4 Whitney Young Magnet; #8 Lane Tech; #11 Infinity Math; #12 Lincoln Park; #14 Lindblom, all of which are Chicago Public high schools.

Where are the schools we are forced to hear about? Well Evanston's New Trier was #15 and Naperville's Nequa Valley was #30. Also please note that all these CPS schools have Special Ed students and by far more minority students than any of the other top schools and the students come from a much lower average family income.

This data is not available to compare these schools to Catholic and other private institutions, many of which are doing a great job serving our children. But it is an acceptable and objective way to compare public schools. When I was the assistant principal at Nathan Davis in 1994, I had a student apply to Kennedy High School. I asked why go so far? The answer, "my Mom says there are white kids there, it must be a better school". I recall two of my boys, when I was principal at De La Cruz, say that they were going to go to St. Rita High School because they have the best football team. Sadly, this is how some people choose their schools. The key is if the students are doing well, they will have choice in the high school they attend. The neighborhood high schools serve thousands of kids well. They key is to go there because you want

to, not because you have to.

The most important reason to bring this up now is that the admission process to these top ranked schools starts NOW for your 7th grader. CPS has adopted the Northwestern Evaluation Association of Measured Academic Progress (NWEA MAP). All current 7th grade students wanting to apply to the CPS selective enrollment schools will be required to take this test next Fall. The registration period has started May 1st. Please go to their website [cpsgoe.org](http://cpsgoe.org)

This information is especially important for our local students who attend schools like John Paul II, St. Barbara or are being home-schooled. The CPS students will get this information at school. Do not let these dates pass you by.

## Vaccinations For School Entrance

Illinois Department of Public Health Director Dr. LaMar Hasbrouck is urging parents to talk with their doctor about the new school-entrance vaccination requirements, and to make sure their child's immunizations are up-to-date. This year marks the 20th anniversary of National Infant Immunization Week, April 26 - May 3, an annual observance to highlight the importance of protecting infants from vaccine-preventable diseases.

One example of the seriousness of vaccine-preventable diseases is the current mumps outbreak in central Illinois. Preliminary numbers show more than 65 cases have been reported so far this year, compared with approximately 26 all of last year and 32 in 2012.

Beginning next year, children entering school at any grade level (kindergarten through 12) need to show proof of having received two doses each (instead of just one) of rubella and mumps vaccines. In addition, any child entering kindergarten, sixth grade or ninth grade for the first time shall show proof of having received two doses of varicella (chicken pox) vaccine.

For school entrance, students must show proof of diphtheria, pertussis, tetanus, polio, measles, mumps, rubella, haemophilus influenza type b, hepatitis b, varicella and pneumococcal (depending on age) vaccinations.
